

## THE BIG PICTURE

The North Carolina Community College System (NCCCS) is the third largest and most comprehensive community college network in the U.S., serving over 600,000 students annually across 58 colleges. With a mission to reduce barriers to postsecondary education and build a globally competitive workforce, NCCCS is investing in data modernization to better support students and meet statewide strategic goals.

But a fragmented LMS landscape—four different platforms across the system-created roadblocks to consistent reporting. Tracking first submissions for FTE funding reports was time-consuming and error-prone for colleges. These challenges became even more urgent with the explosive growth of dual enrollment and the increasing need for real-time intervention.

#### THE DUAL ENROLLMENT CHALLENGE

Over 85,000 high school students are now taking at least one college course in North Carolina—a 10% yearover-year increase. These students often come from underserved are first-generation backgrounds, college-goers, and rely on seamless communication between high schools and colleges to succeed.

Yet, academic advisors were manually emailing instructors for updates. Data silos meant students fell through the cracks—sometimes not realizing a failing grade in a college course would jeopardize their high school graduation.

#### THE INTELLIBOARD SOLUTION

IntelliBoard became the **first full-system analytics platform deployed across NCCCS**—integrating with all LMS platforms (Moodle, Canvas, Blackboard, and D2L) and delivering:

- **First Submission Reports** to document the first sign of engagement for FTE eligibility and financial aid compliance.
- **Learner Success Dashboards** filtered by high school, advisor, or individual student—empowering proactive support.
- **Permissions-based access** so college advisors and high school partners see only their students, without needing direct LMS access.
- **Dual enrollment reports** tailored to Career & College Promise programs, early colleges, and high school partnerships.
- **Automated exports** for communicating student progress back to high schools.
